The Partner does not receive any rights to exclusively sell AgendaX. AE reserves the right to authorize additional Partners in the Partner sales region at any time.

### **3. EXTRACT OF THE REGISTER OF COMPANIES**

The Partner supplies AE with a current extract of the Register of companies, which shows that the Partner is listed as a legal commercial business.

### **4. PRODUCT SUPPORT / MARKETING**

The Partner provides technical support for the product to its customers. The Partner actively promotes the product.
